# **Privacy Policy**

#### Effective Date: July 1, 2022

Sight Sciences, Inc. ("**Sight Sciences**", "**us**", "**we**" or "**our**") respects your privacy and are committed to protecting your rights. The Privacy Policy describes the types of Personal Information we collect, how we store and handle your Personal Information:

- through all web sites, features, or online services that are owned or controlled by us and that post a link to this Privacy Policy (collectively, the "Sites"), whether accessed via computer, mobile device, or otherwise; and
- in the context of our commercial activities including participation in Sight Sciences-sponsored events and provision of our products to physicians, hospitals and other customers (collectively with the Sites, our "Services")

"**Personal Information**" is defined as any information relating to an identified or identifiable natural person ('Data Subject' or 'Individual'); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

## **Types of Personal Information We Collect**

## Information You Provide to Us

We may collect, use, retain, and/or process several types of Personal Information from you, such as:

- As an end user of the Sites, when you interact with us via the "Contact Us" web forms, you may choose to provide us with certain contact Personal Information like your name, job title, email, address, phone number and other data that may be used to identify you as a specific Individual.
- If you are a healthcare professional, you may choose to provide us with information related to your practice and specialism.
- You may provide Personal Information as part of your web submissions to Sight Sciences, but we expect that you limit the Personal Information you provide to only that which is necessary and associated with the nature of your inquiry. It is in our legitimate interest to offer you a means to communicate with Sight Sciences through the Sites to respond to the questions and requests you may have and provide you with information about Sight Sciences and our products you request.
- We may collect contact Personal Information where you attend a Sight Sciences event (e.g., webinar or conference) or engage with us at an event we attend or exhibit at.
- We may collect contact Personal Information from you when you interact with us directly and through our Sites regarding employment with us, including job history and qualifications, background screening information, certain financial information and other information. Please

- Where you otherwise engage with us in connection with our Services or provide services to Sight Sciences, we will collect contact Personal Information and information related to administering our business relationship under a contract with you or the organization you represent or work for, including transaction information and financial information.
- Our Sites are not intended for people under 18 years of age. No one under age 18 may provide any Personal Information to us or on our Sites. We do not knowingly collect Personal Information from people under 18. If you are under 18, do not use or provide any Personal Information on our Sites or through any of its features. If we learn we have collected or received Personal Information from a person under 18 without verification of parental consent, we will delete that information. ## Information We Collect From Other Sources

- Where you are a professional expert or key opinion leader ("KOL") in your medical field, we may collect contact Personal Information and details of your practice, medical specialism and expertise where relevant to our products and services, from published sources.
- We may combine contact Personal Information you provide us with information we collect or receive about you from other publicly and commercially available sources, such as other social media platforms.
- Where you are an officer or representative of a prospective commercial partner or vendor, we may use third party diligence services to verify information about you and/or credentials.

We may combine the information we receive about you and use or disclose it in the manner described in this Privacy Policy.

## Information We Collect Automatically When You Access or Use the Sites; Tracking

We collect certain information, associated with online identifiers when you visit our Sites. We automatically collect technical information about your online interaction and device such as the browser type and language, device operating system and Internet Protocol (IP) Address used to connect your device to the internet and from which we can derive your device country location by reference to the IP. This information is associated with information about your browser page requests as well as dates, times and duration of your use of our Sites. Collecting and tracking this type of information helps us better understand the use and effectiveness of our Sites and is in an aggregated form that is not directly associated by us with any specific named individual information. Subject to compliance with applicable law (see below regarding use of Personal Information), we may use or disclose such aggregated information for any purpose.

Sight Sciences and its third-party service providers use a variety of automatic detection tools such as cookies and similar technologies including embedded web links, pixel tags, flash cookies, and/or web beacons (collectively 'cookies') to passively collect certain information about your use of and visits to our Sites. Cookies typically involve pieces of information or code transferred to or accessed from your device to store and track information about the interaction of your device with online content. Cookies enable you to be remembered when using your device to interact with our Sites and can be used to understand how certain Site features are used and to manage the presentation of online features and content. For information about cookies and similar other technologies, what they do, and how to disable the non- necessary ones, please refer to our full <u>Cookie Policy</u>.

## Our use of your Personal Information

We may use Personal Information we collect or that you provide to us for purposes, such as:

- to respond in our legitimate interest to requests, inquiries and feedback we receive from you or your company or organization;
- to verify and manage, professional status corporate risk, conflicts of interest, security, safety and compliance obligations in our legitimate interest or where required by law and where relevant to our sites, Services or services we receive;
- to take steps to enter into and administer, or enforce any contract relevant to an engagement with you or with the organization you represent or work for;
- to comply with legal and professional obligations relevant to verification, record keeping, health and safety and in assessing and where required, responding to regulatory or lawful requests;
- to analyze the use of our Sites and Services to understand in our legitimate interests (or with your consent where we use certain cookies), how we can improve our Sites and Services;
- in connection with our KOL programs, to develop in our legitimate interests, resources, encourage professional networking and build awareness, understanding and feedback on issues and treatments to which our Services relate; and
- to provide you with promotional materials about our Services relevant content and advertisements, surveys, newsletters, questionnaires, and other materials; in our legitimate interest or where required under applicable law, with your consent.

## Sight Sciences Privacy Practices

## <u>Security</u>

We employ several technical, organizational, and physical safeguards designed to protect the information we collect. However, security risk is inherent in all internet and information technologies and we cannot guarantee the security of your Personal Information.

## How Long We Keep Personal Information

It is our policy and process to keep your Personal Information only for as long as it is warranted to adhere to our terms, conditions, and commitments to you, carry out legitimate interests of the business, and identify, comply to and resolve any legal or regulatory requirements.

#### **Sharing Personal Information with Third Parties**

To the extent consistent with applicable law, we will share your Personal Information in the following circumstances:

- <u>Sight Sciences</u>. We will share information within Sight Sciences and as relevant, its family of companies (i.e., subsidiaries and corporate affiliates) involved in supporting or administering our Sites or Services for the purposes set out in this Privacy Policy, such as responding to your inquiries and providing you information that you have requested;
- <u>Third Party Service Providers</u>. Third party service providers work on behalf of Sight Sciences and help
  us operate our Sites, Services or our business operations (including IT, hosting, software support,
  relationship management, data management, verification services, email delivery, marketing, web
  services, event management services). When third parties process or require access to Personal
  Information, we ascertain that the third party is obligated to provide at least the same level of privacy
  protection as we hold ourselves to. Sight Sciences maintains contracts with these third parties that
  restrict their access, use, and disclosure of Personal Information in compliance with the laws and
  regulations that apply. Our third parties are required to notify us if they determine they can no longer
  meet the level of data protection expected by Sight Sciences, and we monitor for compliance to our
  data protection terms depending on the nature of the services being provided.
- <u>Advisors</u>. We may share Personal Information with our auditors, legal advisors and other professional advisors.
- <u>Our stockholders, investors, finance providers and business partners</u>. We may provide Personal Information in order to provide aggregated reporting data and to otherwise manage and fulfil our agreements with and obligations to our stockholders, investors, finance providers and other business partners.
- <u>Enforcement of Rights/Security</u>. We may disclose information (i) when required by law or in response to a legally binding request for cooperation by a government entity or law enforcement; (ii) to protect and/or enforce the rights, property interests, or safety of us, or any of our respective affiliates, business partners, customers, or employees; or, (iii) to resolve disputes, troubleshoot problems, prevent fraud and otherwise enforce this Privacy Policy and our Terms of Use, as made available from time to time.
- <u>Reorganization of Sight Sciences</u>. In the event we sell or transfer all or a portion of a business or assets to a third party, such as in connection with a merger or in the event of a bankruptcy reorganization or liquidation.
- <u>With Your Consent</u>. We may share your information when you or your company or organization consent to or request such sharing. This includes, but is not limited to, when you provide information through the "Find a Physician" function on our Websites, we may disclose the information to our subsidiaries, affiliates, or to health care providers in your area in order to put you in touch with clinicians.

## International Transfers of Personal Information

We are a US company and the data that we collect from you from our Sites or in connection with our Services will be stored in the USA which (if you are located in another country) may not have equivalent Data Protection Laws to those of your home jurisdiction.

To the extent we receive or make transfers of Personal Information we will take reasonable steps to ensure

that your data is subject to appropriate safeguards, such as relying where appropriate, on any applicable recognized legal adequacy mechanism and ensuring that Personal Information is treated securely and in accordance with this Privacy Policy.

# Important Information for California Residents

California residents are entitled once a year, free of charge, to request and obtain certain information regarding Sight Sciences' disclosure of certain categories of personal information to third parties for their direct marketing purposes in the preceding calendar year.

## How to Exercise Your Rights

You may exercise your California privacy rights to know or delete, as described above, by contacting us as specified in the "How to Contact Us" section of this Privacy Policy.

Only you, or someone legally authorized to act on your behalf, may make a request to know or delete related to your personal information. We reserve the right to confirm your identity and California residency to process your requests to exercise your information, access or deletion rights. As a part of this process, government identification may be required. Consistent with California law, you may designate an authorized agent to make a request on your behalf. - Erasure: In certain circumstances, you may have the right to the erasure of Personal Information that we hold about you (for example if Personal Information is no longer necessary for the purposes for which it was originally collected).
- Data portability: You may have the right to receive the Personal Information concerning you in a structured, commonly used, and machine-readable format that can be shared with another organization. The right of data portability also allows you the opportunity to have Sight Sciences transmit that data to another organization directly where technically feasible.
- Object to processing: You may have the right to request that Sight Sciences stop processing your Personal Information and/or to stop sending you marketing communications.
- Restrict processing: You may have the right to request that we restrict processing of your Personal Information in certain circumstances (for example, where you believe that the Personal Information we hold about you is not accurate or lawfully held).
